  - a. Tigger sold w/ parts & trailer
  - b. 2016 Arctic Cat groomer bought and to be picked up in next few weeks
    - i. Will need breaking in period prior to dragging
    - ii. Proposed session for introduction to Groomer operation (KP)
5. Title 17 update (up for rewrite with Animal Control Board, specifically modification of 20 minute daytime bark clause)
  - a. Proposal for separating mushing facilities vs other multiuse animal facilities to subcommittee 11/16/16
  - b. Christine Roalofs to keep us posted on outcome of proposal
  - c. After subcommittee feedback, proposal then will go to Animal Control Board and then to the Anchorage Assembly
  - d. Good musher representation - Val, Pam, Christine Roalofs, Kim Wells, Paul Badalich all participated - Animal Control Board receptive

  - a. Montana Creek currently has less snow than Chugiak, at this time unlikely to be able to move races there

  - c. Important to keep Business Persons race for club and sponsors
  - d. At this time, will keep races listed as postponed/rescheduled to allow for flexibility later in season, will adjust based on snowfall this winter

  - b. Val will reply with board's input
