- 2. May Minutes MR motion, SC 2<sup>nd</sup>, approved
  - a. Susan won't be coordinating poster, but will assist with graphics
- 3. President's Report
  - a. Chugiak contract from Parks & Rec signed
  - b. Sent races to insurance for refunds, will send 2019-20 schedule soon
  - c. Pulled out by-laws to review for elections in April
- 4. Treasurer's report
  - a. Interest \$16.00, everything else the same
  - b. SC gone September, will meet with Michelle beforehand
  - c. Vote on budget at the August meeting (SC will be gone in July) and amendment for South Central Challenge
- 5. Trail and Property Report
  - a. Trail Committee Report
    - i. Matt and Tom flagged trails for more options which adds 3.0-3.5 miles and has been approved by Birchwood Camp. These additions just need to be added into the contract. Another 3.5 mile addition along the railroad all the way to 8 mile turn off. Above additions don't include Parks & Rec (~6.0 miles)
    - ii. Park & Rec 6 mile extension needs to be flagged, GPS and tracked. Proposal to also bring inlet trail off of Eklutna, straight down green property line
    - iii. Need to close trails during off season to assure only mushing use per Birchwood Camp's request
    - iv. Parks & Rec meeting Monday June 10th at 7:00pm
    - v. Kris has 20 yards of sand that will be delivered around Friday, June 7th for trail repairs
    - vi. Kris mowed the grass on both staging areas Thank you!
